

## BY-LAW 200-30-03

## A BY-LAW RELATING TO THE REPEAL OF BY-LAWS OF THE TOWN OF RIVERVIEW

**BE IT ENACTED** by the Town Council of the Town of Riverview, under the authority vested in it by the <u>Local Governance Act</u>, SNB 2017, c18 as follows:

## 1. TITLE

a. This by-law may be cited as the Repeal By-law.

#### 2. **DEFINITIONS**

In this by-law:

a. "Repeal" means to rescind or annul a by-law that will not be replaced and which has no further need, action or consequence.

## 3. REPEAL OF BY-LAWS

- a. All by-laws (and all amendments thereto) listed in Schedule "A" hereto and forming part of the by-law are hereby repealed.
- b. The repeal of any by-law listed in Schedule "A" hereto shall not in any way affect or void any agreements entered into thereunder.

# 4. REPEAL OF LOCAL IMPROVEMENT BY-LAWS

With respect to the repeal of By-law 300-25-A By-law Relating to Local Improvements in the Town of Riverview, the authority to adopt the following by-laws, which reference the above noted by-law, was given under the authority of Sections 117-148.1 of the <u>Municipalities Act</u>, R.S.N.B. c M-22 and shall remain in effect under the authority of Section 195 of the <u>Local</u> Governance Act, SNB 2017, c18:

# 5. SEVERABILITY

a. If any part of this by-law shall be held invalid, such part shall be deemed severable and any invalidity thereof shall not affect the remaining parts of this by-law.

# 6. BY-LAWS REPEALED

a. By-law 200-30-02, any subsequent amendments and any previous by-laws of the Town of Riverview respecting the *Repeal of By-laws of the Town of Riverview* are hereby repealed.

# 7. ORDAINED AND PASSED
