#### 5. BUSINESS ARISING FROM THE MINUTES

A) Update on CARMA activities – Warren Avenue

And further that an amendment to the Animal Control By-Law be made to providing for provisions to allow staff to use these types of organizations, in addition to the SPCA, in other situations where there is a problem with feral or stray cats.

The members of Council entered a discussion on the ongoing situation on Warren Avenue and confirmed that Town staff had achieved some success and continue to address the issue. Town Council understands that it is a frustrating experience for area residents but would like to continue to work with CA-R-MA and the practise of trap-neuter-return in regard to the feral cat population. Council agreed to implement a six-month deadline in the Warren Avenue instance whereby the matter will be brought back to Council to determine the next course of action if not resolved during this time period.

## 12. COUNCIL STATEMENTS/INQUIRIES

Mr. Ouellet confirmed with Councillor Bennett that it could be weeks and/or months before the installation of the dual flashing beacon (known as a "wig wag" light) at the intersection of Trites Road and Whitepine Road as there is a requirement for tendering which is a process unto itself.

Mr. Ouellet confirmed with Deputy Mayor Macdonald that the Department of Transportation and Infrastructure will supervise the resurfacing of Coverdale Road (Route 11) which is anticipated to begin at the end of September. Once the asphalt pavement is completed they will also reinstate the traffic line markings.

Robert Higson confirmed that a Press Release was issued today by the Communications Department regarding the outstanding water and sewer accounts. He also noted that the *Times-Transcript* will be following up with an interview.

Councillor LeBlanc was happy to report that a resident in the Goldsboro area had come forward and would be taking the lead on that street with respect to a traffic calming review. He noted that this will be the first street to be reviewed under the new Traffic Calming Policy.

Mr. Smith confirmed with Mayor Seamans that the deadline for the surveys on the transit buses is September 18<sup>th</sup>. He noted that, thus far, a significant number of surveys had been completed and once compiled will be great information for Council to consider. Mr. Smith indicated that Council can expect a report on the re-routing options by the end of October.

The concern was raised that the information regarding the buses may not be getting to residents who do not utilize social media. As this is an important issue, Councillors want to engage all the residents not just the ones utilizing social media. Mr. Smith commented that information had been made available to the public through various methods including information being made available at town events, on the Town's web site, and through media coverage.
