Bill Budd conducted a PowerPoint presentation outlining the rationale behind the proposed text changes to the Municipal Development Plan; namely, to establish criteria and guidelines by inserting new policy directions to assist with the evaluation of new radiocommunication towers to ensure their compatibility with surrounding areas. He noted that, in Canada, all communication systems are

governed by Federal legislation and regulations and must be licensed to operate an installation at each specific location. Mr. Budd pointed out that the Town of Riverview is not the approving authority for communication installation. However, as part of the licensing process, Industry Canada requires that the communication companies (known as carriers) seek input from the municipality. Mr. Budd remarked that the Town of Riverview has joined the CRINS organization and in doing so adopted its policies. The next step in the process is the Public Hearing scheduled for January 11, 2016 at 6:30 p.m.

Mayor Seamans declared the public presentation to be concluded at 6:40 p.m.

Mayor Seamans remarked that she wanted the members of Council and the residents of Riverview to be aware of this fund raising campaign. Taken as information.

7. PETITIONS, PRESENTATIONS & DELEGATIONS

- A) **Presentation by J.R. Richard, President, Greater Moncton Santa Claus Parade Committee**

Mr. Richard stated that the Greater Moncton Santa Claus Parade is the biggest parade in Atlantic Canada and the third biggest in Canada. He noted that the Town of Riverview has been a strong supporter of the parade for many years. Next year marks an important milestone as the Greater Moncton Santa Claus Parade marks its 50th year. The theme will be "Fire and Ice" and the Committee is looking for a financial contribution of \$1,000 for 2016. The Cities of Moncton and Dieppe also provide significant financial support to the parade on an annual basis. The additional \$500 being sought from the Town of Riverview (\$1,000 in total) is a one time ask specifically for the celebration of the 50th Anniversary. It was noted that there is an undisclosed amount in the bank account which serve as cushion for incidentals such as repairs to the floats, lights, etc.

E) Acceptance of Lions Community Park Master Plan

That the Town of Riverview accepts the Riverview Lion's Community Park Master Plan as presented and directs staff to utilize the proposed allocated Capital funding from the five (5) year Capital Program to secure additional funding from other levels of government, not-for-profit organizations (including Foundations), the private sector, and individual citizens, with the goal of proceeding with each of the four projects, either in total or as individual projects as indicated in the Master Plan 2015.

It was noted that the First Phase of the Lions Community Park Master Plan is included in the 5 Year Capital Plan; however, this would be subject to review each year. This would be an item to be considered during the 2016 budget deliberations along with the other proposed projects to determine if or how to execute them. The Town is actively pursuing funding but it will be necessary to determine from Council the maximum dollar value they are willing to put into this project. These are the types of questions that will be addressed during the budget deliberations. It was noted that there is a financial commitment of \$5,000 for five years made by the Riverview Clubs. An application has also been submitted by the Town under the Canada 150 program which, if successful, would be made available in 2016-2017 for the Lions Community Park.
