



Council Highlights Regular Council Meeting – March 14, 2016

Public Hearing – Local Improvements on Beverly Crescent, Woolridge Street and Hawthorne Drive

Council received one letter of objection that stated questions related to storm water management on Hawthorne Drive. The Director of Engineering and Public Works told Council that staff have resolved the resident's concerns and the resident is satisfied.
